New Dental Healthcare Service Type Codes Approved!

NDEDIC's Workgroup 1, Dental Service Type Taskforce is pleased to announce that **four new** Dental Service Type Codes (STCs) have been approved by the Healthcare Codes Committee.

Through an NDEDIC led collaborative effort and the support of the American Dental Association, National Association of Dental Plans, the X12 Workgroup 1 and Dental Caucus five dental codes requests were reviewed at the X12 Winter Healthcare Codes Committee meeting with four being approved with an effective date of March 1, 2019.

- **94 Dental** and pre-diagnostic tests and examinations Note: Refer to the American Dental Association Code on Dental Procedures and Nomenclature (CDT Code).
- **95 Periodontal** surgical services Note: Refer to the American Dental Association Code on Dental Procedures and Nomenclature (CDT Code).
- **96 Adjustment** to dentures/repairs to complete dentures, denture rebase procedures, and denture reline procedures Note: Refer to the American Dental Association Code on Dental Procedures and Nomenclature (CDT Code).
- **97 Dental**, non-surgical extractions Note: Refer to the American Dental Association Code on Dental Procedures and Nomenclature (CDT Code).

While the fifth code requested," Treatment of Fractures", was not approved, the NDEDIC request sparked interest with both dental and medical carriers for NDEDIC to lead a collaborative discussion on healthcare service type code for the American Dental Association Code on Dental Procedures and Nomenclature for Oral Surgery. More information regarding this collaboration will be forthcoming.
